

# Run for the Roses Hat Contest

## Official Rules

Non-wagering Contest: “The Run for the Roses Hat Contest” is a non-wagering contest that will take place at Golden Gate Fields on Saturday, May 1, 2010.

### **Eligibility:**

- a) Contest participants must be 18 years or older to win. Proof of age and identity is required to claim prizes.
- b) The following are ineligible to participate in this contest: employees of Golden Gate Fields.
- c) Hats should be original designs – either purchased, borrowed or designed (i.e. baseball caps and non-decorated straw hats will not be considered for prizes).

### **To Enter:**

- a) Register between 9:00am and 1:30pm, the deadline to enter the contest is 1:30pm. Entries will be taken on the Mezzanine level next to Customer Service and in the Turf Club. Must be present at Golden Gate Fields on Saturday, May 1, 2010 to win.
- b) One entry per contestant.

### **Judging:**

- a) Representatives of Golden Gate Fields will select candidates for 1st, 2nd and 3rd place in each category. All winning hats will be selected based on creativity and originality.
- b) All contest participants will report to the Winner’s Circle after the 5<sup>th</sup> race at Golden Gate Fields on Saturday, May 1, 2010. The 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place winners in each category will be announced in the Winner’s Circle at this time.
- c) Eligibility for prizes is limited to the person who signs this entry form.
- d) Judges’ decisions are final.
- e) Must be present to win.
- f) All contest participants will receive two free Club House admission passes.

### **Hats Categories:**

- 1) Best Racing Theme
- 2) Funniest or Most Outrageous
- 3) Most Glamorous

### **Prizes:**

First place in each category-\$200  
Second place in each category-\$100  
Third place in each category-\$50

All Hats Contest entrants will receive two free passes to the races
